

RESOLUTION DIRECTING PLACEMENT
OF STOP SIGNS ON EAST MAIN STREET AT HIGH STREET
VILLAGE OF BRADFORD

RESOLUTION NUMBER 07/08 - 3

A RESOLUTION directing the placement of stop signs on East Main Street at High Street in Village of Bradford, Stark County, Illinois;

WHEREAS the President and Board of Trustees of the Village of Bradford (the "Corporate Authorities") have determined that for the safety of the residents of the Village, and because of the proximity of the Bradford Junior High School and Grade School, it is advisable, necessary and in the best interests of public health, safety and welfare to have stop signs placed on East Main Street at High Street in the Village;

NOW, THEREFORE be it ordained by the President and Board of Trustees of the Village of Bradford, Stark County, Illinois, as follows:

SECTION 1. The Corporate Authorities hereby direct the placement of stop signs on East Main Street at High Street in Village of Bradford, requiring traffic in both directions on East Main Street to stop at its intersection with High Street.


SECTION 2. If any section, paragraph, clause or provision of this Resolution is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Resolution.

SECTION 3. All ordinances, resolutions, orders, or parts thereof, which conflict with the provisions of this Resolution are, to the extent of such conflict, hereby repealed.




