



A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION FOR A COMMUNITY DEVELOPMENT ASSISTANCE PROGRAM (CDAP) GRANT FROM THE ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY (DCEO)

WHEREAS, the Village wishes to submit an application to DCEO for a CDAP grant for the construction of the West Main Street water distribution system improvements project for consideration in the PY 2010 competition; and

WHEREAS, in order to submit such an application properly, the Village Board must first officially approve the project for which the funds are being sought and authorize the President as chief executive officer to sign the application forms and he and the Clerk to execute all appropriate documents to facilitate the filing of the application; and

WHEREAS, in filing this application, the Village fully understands that many rules and regulations set forth by the federal government and State of Illinois as indicated in the application will apply to the project which the Village must comply with if the project is funded; **NOW**

THEREFORE BE IT RESOLVED by the Board of Trustees of the Village of Bradford that the President be authorized to sign the CDAP application and execute all other necessary documents; that the Clerk be authorized to attest to, certify and otherwise execute all necessary documents for the CDAP application; and that both the President and Clerk be empowered to submit any information for the application subsequent to its filing as may be requested by DCEO; and

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect from and after its passage in accordance to law.


