ANNUAL TAX LEVY ORDINANCE

WHEREAS, the President and Board of Trustees of the Village of Bradford, Stark County, Illinois, did previously pass and adopt the Annual Appropriation Ordinance for said Village for the fiscal year beginning on May 1, 2016, and ending on April 30, 2017 which said Appropriation was duly published as required by statute.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bradford:

SECTION 1: That there be and is hereby levied upon all property within the corporate limits of the Village of Bradford subject to taxation for the year 2016, the total sum of \$12,650.03 for the General Fund.

SECTION 2: That there be and is hereby levied upon all taxable property within the corporate limits of the Village of Bradford subject to taxation for the year 2016 the total sum of \$43,573.77 for the following specific purposes by law, which amount so levied shall be exclusive of and in addition to the taxes levied for general corporate purposes as follows:
