

Ordinance No. 07/08 - 16
VILLAGE OF BRADFORD,
Stark County, Illinois

**AN ORDINANCE PROHIBITING DUMPSTERS AND
COMMERCIAL STORAGE CONTAINERS IN
RESIDENTIAL DISTRICTS
IN THE VILLAGE OF BRADFORD**

WHEREAS, the Village Board has determined that dumpsters and commercial storage containers in residential districts may create a nuisance and should be regulated;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADFORD, STARK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE. No person shall place a dumpster or commercial storage container in any residential district in the Village except as follows:

1. In multiple-family, business and commercial districts where receptacles of a larger capacity are necessary, commercial containers or dumpsters may be used and the following conditions shall be maintained by every owner and occupant of any premises in such districts:
 - a. Commercial containers or dumpsters must be of sufficient capacity to contain all garbage between pick ups, and
 - b. Commercial containers or dumpsters must be covered with close fitting covers, unless such containers or dumpsters contain no animal, vegetable or food wastes.
2. The Village President may issue a Permit for placement in a residential district of a dumpster or commercial storage container temporarily for periods of up to 30 days during construction, remodeling, demolition, special events, or other valid temporary purpose.

SECTION TWO. Any person found to be in violation of this section shall be subject to a fine of not less than \$25.00 and not more than \$750.00.

SECTION THREE. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION FOUR. This Ordinance shall be in full force and effect ten days after its passage and publication as provided by law.


