AN ORDINANCE REQUIRING NUMBERING OF BUILDINGS AND LOTS

WHEREAS, the Village President and Village Board of the Village of Bradford have deemed it in the public interest to establish a plan for numbering all buildings, structures and lots in the Village pursuant to the authority granted under 65 ILCS 5/11-80-18; and,

WHEREAS, it is in the best interests of public that structures and improvements within the Village be viably marked with the established number for each such structure and improvement according to the plan established by the Village Board;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE VILLAGE BOARD OF THE VILLAGE OF BRADFORD, STARK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE. All lots, buildings and structures in the Village shall be numbered in accordance with the plan formulated therefor, approved by the Village Board and on file in the office of the Village Clerk.

SECTION TWO. The Village Clerk shall keep a chart showing the proper street number of every lot in the Village, which chart shall be open to inspection by any interested person.

SECTION THREE. It shall be the duty of the owner and occupant of every building in the Village to have placed thereon in a place visible from the street, figures at least two (2) inches high showing the number of the building.

SECTION FOUR. This Ordinance shall be in full force and effect ten days after its

passage and publication as provided by law.
