

AN ORDINANCE ESTABLISHING THE OFFICE OF VILLAGE COLLECTOR AND DESIGNATING VILLAGE CLERK TO HOLD OFFICE

IN THE VILLAGE OF BRADFORD

WHEREAS, the President and Village Board of the Village of Bradford, Stark County,
Illinois, are duly empowered by authority provided for Municipal Government in the Illinois
Compiled Statutes to establish the office of Village Collector, and provide that the such Office be held by the Village Clerk;

NOW, THEREFORE, Be It Ordained by the President and Village Board of the Village of Bradford, Stark County, Illinois, as follows:

<u>Section 1. CREATION OF OFFICE</u>: The office of Village Collector is hereby established with the powers, duties and responsibilities as provided for under the Illinois Municipal Code.

<u>Section 2. APPOINTMENT</u>: The Village Clerk shall hold the office of Village Collector, and shall be separately compensated therefor.

Section 3. REPEAL OF CONFLICTING PROVISIONS: All ordinances or parts of ordinances in conflict herewith to the extent of such conflict are hereby repealed. If any section, paragraph, clause or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalid or unenforceable section, paragraph, clause or provision shall not affect any of the remaining provisions of this ordinance.

<u>Section 4.</u>: This ordinance shall be in full force and effect upon its passage and publication as provided by law.
