AN ORDINANCE TO AMEND THE VILLAGE LIQUOR ORDINANCE

WHEREAS, the Board of Trustees of the Village of Bradford has determined that the Village Liquor Ordinance should be modified to expressly require license holders to obtain and provide evidence of having a liquor license from the State of Illinois and Dram Shop insurance coverage prior to lawfully selling alcohol or offering it for sale;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADFORD, STARK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE. That Chapter 3 "Liquor", Article 3, Section 51 is amended to read and shall be as follows:

Sec. 3-3-51. Required.

- (a) It shall be unlawful for any person, either by himself or his agent, or any person acting as an agent, barkeeper, clerk or servant of another, to sell or offer for sale at retail in the village any alcoholic liquor without first having obtained a license to do so issued by the local liquor control commissioner and by the State of Illinois. The local liquor control commissioner may require documentary proof of compliance with this provision.
- (b) It shall be unlawful for any person, either by himself or his agent, or any person acting as an agent, barkeeper, clerk or servant of another, to sell or offer for sale at retail in the village any alcoholic liquor without first having obtained Dram Shop insurance coverage. The local liquor control commissioner may require documentary proof of compliance with this provision.
- (c) It shall be unlawful for any such person to sell or offer for sale any alcoholic liquor in violation of the terms and conditions of such license.

SECTION TWO. All Ordinance or parts of Ordinances in conflict herewith are hereby repealed.

SECTION THREE. This Ordinance shall be in full force and effect ten days after its passage and publication as provided by law.


