AN ORDINANCE TO AMEND THE VILLAGE CURFEW ORDINANCE

WHEREAS, the Board of Trustees of the Village of Bradford has determined that the Curfew Ordinance should be modified to clarify the curfew hours;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADFORD, STARK COUNTY, ILLINOIS, AS FOLLOWS:

That Article 3, Chapter 4 "Curfew", Section 1 is amended to read SECTION ONE. and shall be as follows:

Sec. 6-4-1: Hours.

It shall be unlawful for any person less than eighteen (18) years of age to be present at or upon any public assembly, building, place, street, highway or park at the following times unless accompanied and supervised by a parent, or legal guardian, or other responsible adult as authorized by a parent or legal guardian, or unless engaged in a business or occupation which the laws of Illinois authorize for a person less than eighteen (18) years of age to be engaged in:

- (A) Between the hours of 11:00 p.m. Sunday and 6:00 a.m. Monday;
- (B) Between the hours of 11:00 p.m. Monday and 6:00 a.m. Tuesday;
- Between the hours of 11:00 p.m. Tuesday and 6:00 a.m. Wednesday; (C)
- Between the hours of 11:00 p.m. Wednesday and 6:00 a.m. Thursday; (D)
- Between the hours of 11:00 p.m. Thursday and 6:00 a.m. Friday; (E)
- Between the hours of Midnight Friday and 6:00 a.m. Saturday; (F)
- (G) Between the hours of Midnight Saturday and 6:00 a.m. Sunday.

SECTION TWO. All Ordinance or parts of Ordinances in conflict herewith are hereby repealed.

SECTION THREE. This Ordinance shall be in full force and effect ten days after its passage and publication as provided by law.
