## ANNUAL TAX LEVY ORDINANCE 2012

WHEREAS, The President, and the Board of Trustees, of the Village of Bradford, in the County of Stark, and State of Illinois, did previously pass the Annual Budget And Tax Appropriation Ordinance, for the Village of Bradford, for the fiscal year, beginning on May 1, 2012, and ending on April 30, 2013;

NOW, THEREFORE, BE IT ORDAINED, By the President, and the Board of Trustees, of the VILLAGE OF BRADFORD, in the County of Stark, and State of Illinois, as follows:

Section 1. That the sum of \$14,000.00 be, and the same is hereby Levied, upon all of the taxable property, within the Corporate Limits, of the Village of Bradford, in the County of Stark, and State of Illinois, as a Tax, for GENERAL CORPORATE PURPOSES, for the Village of Bradford, for the current fiscal year; the same being the amount of money, heretofore Appropriated, for such GENERAL CORPORATE PURPOSES, for the Village of Bradford, by the President, and the Board of Trustees, thereof, less the amount to be realized and derived from other sources of income and revenue, and necessary to be raised, by Taxation; the several GENERAL CORPORATE PURPOSES, for which the same are Levied and for which the amounts of the Tax are to be used, are as follows:

Amount <u>Levied</u>

There is Levied by this Ordinance, for General Corporate Purposes, the sum of:

\$14,000.00

Section 2. That the following sums are hereby Levied upon all of the taxable property within the Corporate Limits, of the Village of Bradford, in the County of Stark, and State of Illinois, for the SPECIAL TAXES VOTED for the current fiscal year, the same being the amounts of money heretofore appropriated for such purposes, less the amounts, if any, to be realized and derived from other sources of income and revenue, and necessary to be raised by taxation; the several purposes, for which the same are Levied, and for which the amounts of the Taxes are to be used, are as follows:

And there is also Levied by this Ordinance, in addition to all other Taxes Levied hereby, for Garbage Disposal Purposes, a Special Tax voted, the sum of:	\$9,200.00
And there is also Levied by this Ordinance, in addition to all other Taxes Levied hereby, for Audit Purposes, a Special Tax voted, the sum of:	\$5,750.00
And there is also Levied by this Ordinance, in addition to all other Taxes Levied hereby, for Social Security Purposes, a Special Tax voted, the sum of:	\$12,000.00
And there is also Levied by this Ordinance, in addition to all other Taxes Levied hereby, for Chlorination Purposes, a Special Tax voted, the sum of:	\$950.00
And there is also Levied by this Ordinance, in addition to all other Taxes Levied hereby, for Police Protection Purposes, a Special Tax voted, the sum of:	\$3,600.00
And there is also Levied by this Ordinance in addition to all other Taxes Levied hereby, for Liability Insurance Purposes, a Special Tax voted, the sum of:	<u>\$11,500.00</u>
Total Special Taxes so Levied:	\$43,000.00
Section 3. There is hereby Levied the aggregate sum of:	

to be raised by Taxation and Levied on all of the Taxable Property in the said VILLAGE OF BRADFORD, in order to meet and defray all of the necessary expenses and liabilities of the said VILLAGE OF BRADFORD, for GENERAL CORPORATE PURPOSES and the various purposes as specified for the SPECIAL TAXES VOTED, as required by Statute or voted by the People of the

TOTAL LEVY:

\$57,000.00

VILLAGE OF BRADFORD, in accordance with Law; and, it is hereby DIRECTED that the aforesaid sum be raised by Taxation, in the manner provided by Law.

Section 4. The Village Clerk, of the Village of Bradford, in the County of Stark, and State of Illinois, is hereby DIRECTED to file a duly Certified Copy of this Annual Tax Levy Ordinance, in the Office of the County Clerk, of the County of Stark, in the State of Illinois, on or before the last Tuesday in the Month of December, 2012; and, the said County Clerk, of the County of Stark, is hereby AUTHORIZED and DIRECTED to extend the Municipal Tax so Levied, by this Annual Tax Levy Ordinance, according to Law, against all the Taxable Property within the Corporate Limits of the Village of Bradford, in the County of Stark, and State of Illinois, for the Corporate Uses, of the Municipal Corporation, of the Village of Bradford.

<u>Section 5</u>. This Annual Tax Levy Ordinance shall be in full force and effect, from and after its passage, approval, and publication, as required by Law.
