#### RULES AND REGULATIONS REGARDING PEDDLERS

#### SECTION ONE.

#### 1. Definition.

As used in this article, the term "peddler" shall mean every person who shall sell or offer for sale, barter or exchange, at retail, any goods, wares or merchandise by traveling from place to place in, along and upon the streets, avenues, alleys or public thoroughfares of the Village; or who shall sell and deliver from any vehicle goods, wares or merchandise, by going from place to place in the Village, whether to regular customers or not. The term shall also mean every person who moves from house to house or from place to place in the Village selling or taking orders for goods, wares, subscriptions or merchandise for future delivery. The term shall not include the following persons:

- a. Sellers of milk and cream.
- b. Farmers, fruit growers and gardeners who sell the produce of their farm, orchard or vineyard.
- c. Sellers or deliverers of newspapers.
- d. Sidewalk and public place vendors as defined in article XII of this chapter.
- e. Persons, who without receiving any compensation for their services, solicit contributions or sell goods, wares or merchandise for civic, patriotic, fraternal, educational, religious or benevolent organizations.
- f. Persons who are registered pursuant to SECTION ONE, 3(viii) who sell goods, wares and merchandise on Village-owned public grounds as part of an event which has been approved by the Village manager.
- g. Persons who sell at events which are sponsored by civic, patriotic, fraternal, educational, religious or benevolent organization goods, wares or merchandise which they have made themselves such as handicrafts and home-sewn items.
- h. Deliverers of goods, wares or merchandise that have been preordered or prearranged.

#### 2. Restrictions.

a. Vehicles, stands and carts used for peddling shall not be operated from fixed locations and stops shall only be made to service customers.

- b. No one shall engage in the business of a peddler between the hours of 9:00 p.m. and 9:00 a.m.
- c. No peddler shall park or stand within 200 feet of a playground or school during the time that organized recreational activities are in progress.
- d. No person shall engage in the business of peddling at any residence or business at which there is displayed upon or near the main entrance door a weatherproof card, approximately three inches by four inches, which states on of the following:

#### NO PEDDLERS ALLOWED

or words to the same effect. Lettering on such signs shall be at least one-third inch in height.

e. No peddler shall remain at any residence after being asked by an occupant to leave.

#### 3. License

- a. No person shall engage in the business of a peddler without first obtaining a license to do so.
- b. An application for a peddler's license shall be made in writing to the Village Clerk which shall set forth the following:
  - i. The name of the individual applying for the license.
  - ii. The residence, telephone number and driver's license number of the applicant.
  - iii. The address of the principal place of business of the applicant and its telephone number.
  - iv. If the applicant is employed by another person or entity, the name of the employee, its address and telephone number.
  - v. Whether the applicant has been convicted of a criminal offense or ordinance violation (other than traffic or parking offenses) in any jurisdiction and, if so, a list of such convictions with date and prosecuting jurisdiction.
  - vi. A State of Illinois sales tax number or other evidence that the business is registered with the state department of revenue.
  - vii. The applicant for a peddler's license under this division shall pay to the Village Treasurer prior to filing an application a fee of \$60.00 per calendar year or part thereof. Should the application be denied, the license fee shall be refunded to the applicant.
  - viii. The Village Clerk shall issue the license required by this division unless he shall find:
    - 1. That the applicant is under the age of 14.
    - 2. That the applicant has been convicted or completed any sentence of imprisonment within the last five years of any offense relating to theft, burglary or fraud, or the applicant has ever been convicted of any felony sex offense as defined in the Illinois Criminal Code of 1961, 720 ILCS 5/1-1 et seq., felony offense related to use of a firearm, manslaughter, first or second degree murder as defined by the Illinois Criminal Code of 1961, 720 ILCS 5/1-1 et seq. or home invasion as defined by the Illinois

- Criminal Code of 1961, or any similar offense under the laws of United States or another state.
- 3. That the applicant or his employer has had a license issued pursuant to this division revoked for cause.
- 4. That the applicant or his employer has had an application submitted pursuant to this article denied by the comptroller within the last three years.
- 5. That the applicant, its partners, officers or listed shareholders has knowingly furnished false or misleading information on any application for a license required under this article or any investigation into any such application.
- 6. An applicant may appeal the denial of a license to the Village Board President by serving written notice of such appeal to the Village Board President within five days of receiving written notice of denial from the Village Clerk
- ix. All licensees under this division shall have in their possession at all times while engaging in business as a peddler the license issued to them by the Village and shall show it to any person who requests to see it.

**SECTION TWO.** No person or organization shall peddle within the Village of Bradford without a license. (ILCS Ch. 625, Act 5, § 11-1416) Penalty, See Ordinance 15-16-08

**SECTION THREE**. All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**SECTION FOUR.** Severability. If any section, subsection, sentence, clause, phrase, or word of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The council hereby declares that it would have passed this ordinance and each sections, subsections, sentences, clauses, phrases, or words thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases, or words have been declared invalid or unconstitutional, and if for any reason this ordinance should be declared invalid or unconstitutional, then the remaining ordinance provisions will be in full force and effect.

SECT	ION FIVE.	This ordinance shall be in full force and effect on January 1 <sup>st</sup> , 2018.
